

Coronado Rotary Low Tide Ride & Stride
Participation Agreement and Release of Liability

I, the undersigned, hereby certify on my behalf, or on behalf of my child covered by this agreement, that I, or my child, will voluntarily participate in the Rotary Club of Coronado Low Tide Ride & Stride (LTR&S) to be held on June 22, 2019 and that I am, or my child is, free to withdraw at any time. I understand and agree that I am responsible for my own well-being, or my child's well-being, during my, or my child's, participation. I, or my child, will follow all instructions and directions given to me, or my child, during the LTR&S. I represent that I am, or my child is, physically able to participate in the LTR&S and will be on the date of the LTR&S. The administrators may remove me, or my child, from the event if they believe that my health, or that of my child, may be endangered.

Participating in the LTR&S involves walking, running or riding a bike along a 5-mile ocean beach course at low tide. The beach surface is not consistent, can vary from extremely soft to hard, slopes as it approaches the water and can include rocks and other debris. Forces applied to the body during walking or running on the beach can result in injury to feet, ankles, legs, knees and hips. Inconsistent beach surface makes bike riding difficult and can lead to falls and resulting injuries. I fully understand and appreciate the risks involved in participating in the LTR&S, which include the risks of serious personal injury, death or disability from accident, exposure, overexertion, adverse weather conditions, or equipment failure, as well as unforeseen risks.

I expressly and voluntarily assume all risk of injury and damage to, or loss of, property to the full extent allowed by law, however caused, even if caused by the negligence in whole or in part of Rotary Club of Coronado, its directors, officers, members and employees, the City of Coronado, the U.S. Navy, the event sponsors, the event directors, the event volunteers or any other affiliated individual.

I understand Rotary Club of Coronado, its directors, officers, members and employees as well as others that may be involved in the LTR&S are not medically trained to care for any physical or medical problems that I, or my child, may have or that may occur.

In consideration of being allowed to participate in the LTR&S, I, on my behalf, or on behalf of my child, hereby forever waive, release, discharge and hold harmless Rotary Club of Coronado and its directors, officers, members and employees, the City of Coronado, the U.S. Navy, California State Parks, the event sponsors, the event directors, the event volunteers or any other affiliated individual, from and against any and all liability claims, demands, expenses, fees, suits, proceedings, actions, and causes of actions, of any and every kind and nature, arising out of, or in any way connected with, my, or my child's, participation, even if that liability arises out to negligence or carelessness or any released party.

I give permission to use any photographs, videotapes, or other recordings of me, or my child, that are made during the course of this event for Rotary promotional purposes.

I have carefully read and understand this Agreement. No oral agreements, representations, statements or inducements, apart from those contained in this Agreement, have been made. I understand that by signing this Agreement I am giving up substantial legal rights. This Agreement shall be binding upon my heirs, administrators, executors, and assigns.
